The qualification is delivered and assessed completely online, therefore, it is accessible to all, regardless of geographical location.

ABOUT THE LEVEL 3 ASSESSOR QUALIFICATION

The Level 3 Certificate in Assessing Vocational Achievement comprises of three units. The MAP-IQ route to qualification is unique as it offers a fourth unit with a specific focus on assessment in non-surgical cosmetic practice.

Unit 1: Understanding the principles and practices of assessment.

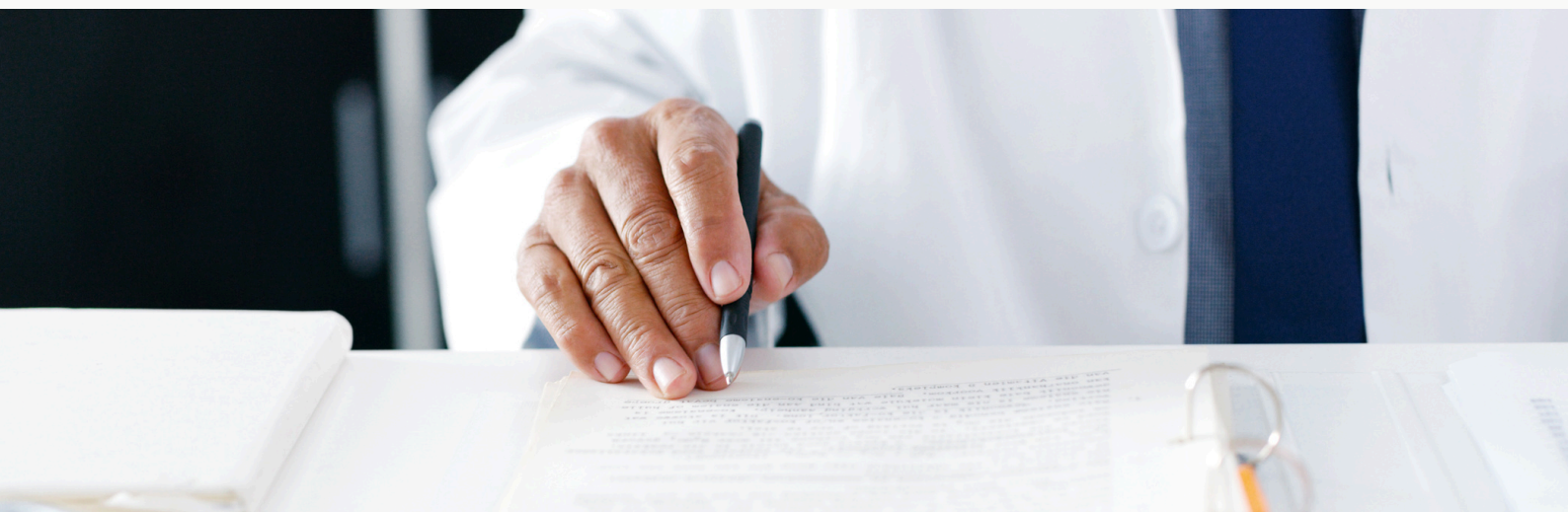
Unit 2: Assess occupational competence in the clinical work environment.

Unit 3: Assess vocational skills - knowledge and understanding.

Unit 4: Assess underpinning knowledge and clinical skills in non-surgical cosmetic practice.

Each unit has a set of learning outcomes that are mapped to the relevant National Occupational Standards (NOS) and Joint Council of Cosmetic Practitioners (JCCP) education and training standards.

THE ASSESSMENT PROCESS

Learner competency is assessed through a three-stage assessment process.

STAGE 1 WRITTEN ASSIGNMENT

Stage 1 of the assessment process requires the learner to complete a written assignment in the form of short answer questions (SARs) to evidence competency to meet the learning outcomes for unit 1.

STAGE 2 KNOWLEDGE ASSESSMENT

Stage 2 requires the learner to complete two knowledge-based assessments with two different learners to demonstrate competency to meet the learning outcomes for unit 3.

STAGE 3 PRACTICAL SKILL ASSESSMENT

Stage 3 requires the learner to conduct two practical skill assessments with two different learners to demonstrate competency to meet the learning outcomes for unit 2.

Stage 1 - is flexible and conducted in the learners' own time and submitted to MAP-IQ for assessment.

Stage 2 - is flexible and conducted in the learners' own time and submitted to MAP-IQ for assessment.

Stage 3 - is flexible and conducted in the learners' clinical environment and assessed via an online platform.

Both new learners and RPEL learners have to undertake the three-stage assessment process.

ENTRY REQUIREMENTS

As with any other field of practice, you will need to be 'occupationally competent' and experienced in the area that you will be assessing.

It should be noted that the MAP-IQ assessor qualification has been purposely designed to support assessment in non-surgical cosmetic injectable practice.

Applicants are required to meet the following criteria

- Foundation training in botulinum toxin and soft tissue fillers
- Hands-on experience in administering botulinum toxin and soft tissue fillers.

- Hold full indemnity insurance cover for aesthetic procedures (must include botulinum toxin and dermal fillers),
- International practitioners must hold an English language level of IELTS 7.0 in all components or equivalent if English is not a first language your first language.
